Personal information

In connection with the execution of the online activities initiated by you (for example Using the contact form, creating an account or placing an order) we do not collect any personal data, e. g. company, name, first name, address, telephone number, e-mail address (all above together also "online offers"). Beyond this, we do not collect any personal data unless you provide this information voluntarily, for example as part of an enquiry by e-mail or telephone or the order of the e-mail newsletter. The aforementioned types of personal data are stored by us.

We collect and store such personal data only if and to the extent that the German Federal Data Protection Act of Germany (Bundesdatenschutzgesetz – BDSG) or other applicable legal provisions permit this or if you have given your consent as the party concerned.

Insofar as we provide you as our customer/user via the service or free online offers the technical prerequisites to carry out a data processing on your part, we are commissioned data processor in the sense of § 11 BDSG – in this case you are responsible as our customer/user.

Purpose of data use

Execution of contracts and free offers: The personal data collected by us will be used (i. e. processed and used) primarily for the establishment and execution of contractual relationships as well as for the execution of the activities initiated by you (for example Free-of-charge website usage options, ordering the e-mail newsletter), and to answer your questions or to give you access to certain information or offers.

Marketing: We also use personal data for the maintenance of existing customer relationships, e. g. for the maintenance of customer relationships like conducting online surveys and sending product and customer information, including information from our associated shops such as maskworld.com, andracor.com, supremereplicas.com or superepic.com, as the case may be.

Consent: To the extent that consent is required for sending product information or conducting market research (together "advertising purposes") in accordance with the applicable legal provisions, such information will only be sent if you have given us your consent. You can then revoke your consent at any time with effect for the future; and even in cases where no consent is required for the commercial use of your data, you can object to the use of data for advertising purposes at any time by notifying support@andracor.com. After receiving your objection or revocation of a previously given consent, we will cease using the relevant data for advertising purposes.

In addition, we reserve the right to save your first and last name, your postal address and – insofar as we have received this additional information from you within the framework of the contractual relationship – your title, academic degree, year of birth and your professional, industry or business name in summarized lists and to use them for our own advertising

Other matters: In anonymized form, we also use the data collected when using our online offers to prepare analyses and evaluations that can be used for statistical or marketing purposes. These include e. g. Analyses of the intensity of use of our online offers and the popularity of individual offers or functions. In addition, we reserve the right to use personal data for other purposes permitted by the applicable data protection regulations, in particular to maintain data security and to prevent or clarify malfunctions and misuse of our online offers (e. g. through intentional attacks on computer systems), to improve our offers or to commission third parties as subcontractors to carry out technical or administrative services. Finally, the use of data may also be necessary due to legal obligations or official or judicial orders, as well as to establish or safeguard legal claims or to defend against legal actions.

Email newsletter

If you subscribe to our newsletter, we use the data required for this purpose or provided by you separately to send you our e-mail newsletter on a regular basis. We will also send you customer information, such as a reminder email in the event of an interrupted purchase or an email on your birthday, if you have specified the date. Data transfer

Personal data is passed on to IT service providers commissioned by us, in particular data center operators who have access to personal data from our area of responsibility. In certain cases, it may be necessary to transfer personal data to third parties who are not established within the EU or the European Economic Area (EEA). We will only transfer your data to such third parties outside the EU/EEA if we can ensure that they guarantee a sufficient level of data protection or if you have given us your express consent to the disclosure. In order to fulfill the contract, we also pass on your data to the shipping company commissioned with the delivery, as far as this is necessary for the delivery of ordered goods. Depending on which payment service provider you choose in the order process, we pass on the payment data collected for this purpose to the credit institution commissioned with the payment and, if applicable, to the payment service provider commissioned by us or to the selected payment service, in order to process payments. Some of the selected payment service providers also collect this data themselves, if you create

We are entitled to examine the risk of non-payment on the buyer's side to the extent permitted by law, for the purpose of deciding on the justification, execution or termination of the purchase contract. Automatically collected non-personal data

When you access our website, information is occasionally collected automatically (i. e. not via registration) that cannot be attributed to a specific or identifiable person (e. g. Security

We regularly review our system for potential vulnerabilities and attacks, using a system-level access-protected data center to protect the information you store on our servers. However, since the Internet is not a one hundred percent secure environment, we cannot assume any warranty or liability for the security of the data you transmit to us via Internet. There is no guarantee that information will not be accessed, disclosed, modified or destroyed as a result of the breach of our physical, technical and organizational security measures.

Integration of third-party services and content

It is possible that third-party content such as videos from YouTube, maps from Google Maps, RSS feeds or graphics from other websites may be included in our online content. This always presupposes that the providers of this content (hereinafter referred to as "third-party providers") perceive the IP address of the users.
